Subject: Safeguards for Implementation of Haryana Govt. Notification dated 15.10.2015 regarding Prescription of Whole Blood and Blood Components by B.A.M.S. / other Alternative Medicine Doctors.


Please find enclosed Govt. notification no. CHD/0093/2015-2017 dated 15.10.2015 regarding the amendment in sub-clause iii) of clause (ee) of rule 2 of Drugs and Cosmetics Act 1940 in which amendment is as under:-

"Every registered medical practitioner holding the qualification specified in the second, third or the fourth Schedule to the Indian Medicine Central Council Act, 1970 (Central Act 48 of 1970) and Part-1 of the Schedule of the Punjab Ayurvedic and Unani Practitioner Act, 1963 (Haryana Amended) (Act 42 of 1963) and registered in the Medical Register of the State maintained under the aforesaid Acts declared as a person practising the modern scientific system of medicines for the purposes of Drugs and Cosmetics Act, 1940 (Central Act 23 of 1940).

A letter issued by State Drug Controller No. 1199-1232 dated 24.02.2016 interpreting the amendment in relation to blood, blood components and blood products is also enclosed for your reference.

In order to implement this notification, safeguards to ensure safety of patients and rational use of blood are being issued as under:-

1. Whole Human Blood, Blood Component and Blood be transfused only when there are no other alternatives to blood transfusion available/feasible. Blood transfusion be conducted only as life saving situation and not as a routine treatment strategy as it is risky procedure and may lead to serious complications/adverse reactions. All doctors may be sensitized to avoid unnecessary blood transfusions and use other alternatives wherever possible.
2. The practitioners must have experience of at least 01 year for transfusion of blood in a hospital/clinic where blood transfusions are regularly conducted. He must also undergo training for rational use of blood before starting prescription of blood.
3. The practitioners must have indoor facility/clinic/hospital for patients and must be providing services where requirement of blood as a life saving measure which can be justified.
4. The hospital/clinic where the blood is to be transfused must have all the equipments for blood grouping, cross match etc., trained paramedical personnel having requisite qualification and facilities for transfusion and also Emergency Services for treatment in case of adverse reaction due to blood transfusion.
5. The hospital/clinic where the blood is to be transfused must have the facility of storage of blood as per the provisions of Drugs and Cosmetic Act, 1940 and Rules made there under, so that the blood may be stored at required temperature during the quarantine period for transfusion.
6. Transfusion Reaction form in case of adverse reaction must be submitted back to blood bank for the purpose of investigation as per norms for safety of patients.



Notification

The 15th October, 2015

No. 7/33/2015-4HB-IV.— WHEREAS, the rights of practitioners of Indian System of Medicine are protected under Section 17(3) (b) of the Indian Medicine Central Council Act, 1970 (Central Act 48 of 1970).

AND WHEREAS, as per Section 2 (1) (e) of the said Act "Indian Medicine" means the system of Indian Medicine commonly known as Ashtang Ayurveda, Siddha or Unani Tibb whether supplemented or not by such modern advances, as the Central Council of Indian Medicine may declare by notification from time to time;

AND WHEREAS, the Central Council of Indian Medicine in its Notification F.No. 28-5/2004-AY(MM), dated the 19th May, 2004, has clarified the word "Modern Advances" in clause (e) of Section 2 (1) of the said Act as advances made in the various branches of modern scientific medicine in all its branches of internal medicine, surgery, gynaecology and obstetrics, anaesthesiology, diagnostic procedures and other technological innovation made from time to time and declare that the courses and curriculum conducted and recognized by the Central Council of Indian Medicine are supplemented with such modern advances.

And whereas, the Central Council of Indian Medicine has improved and strengthened the syllabi of Indian Medicine by including subjects with regard to National Programmes like National Malaria Eradication Programmes, Tuberculosis, Leprosy, Family Welfare Programme, Reproductive and Child Health Programme, Immunisation Programme, AIDS, Cancer etc.

Now, therefore, under sub clause (iii) of clause (ee) of Rule 2 of Drugs and Cosmetics Rules, 1945 the Governor of Haryana hereby declare every registered medical practitioner holding the qualification specified in the second, third or the fourth Schedule to the Indian Medicine Central Council Act, 1970 (Central Act 48 of 1970) and Part-I of the Schedule of the Punjab Ayurvedic and Unani Practitioner Act, 1963 (Haryana Amended) (Act 42 of 1963) and registered in the Medical Register of the State maintained under the aforesaid Acts, as a person practising the modern scientific system of medicine for the purposes of Drugs and Cosmetics Act, 1940 (Central Act 23 of 1940).
